

PERFORMANCE CURVES





COLLECTOR-EMITTER VOLTAGE VCE (V)

COLLECTOR-EMITTER SATURATION




GATE-EMITTER VOLTAGE VGE (V)






COLLECTOR CURRENT Ic (A)

FREE-WHEEL DIODE FORWARD CHARACTERISTICS (TYPICAL)




EMITTER-COLLECTOR VOLTAGE VEC (V)




