

Figure 1. Average forward power dissipation versus average forward current




Figure 2. Average forward current versus ambient temperature ($\delta = 0.5$)




Figure 3. Normalized avalanche power derating versus pulse duration




Figure 4. Relative variation of thermal impedance junction to case versus pulse duration




Figure 5. Reverse leakage current versus reverse voltage applied (typical values)





Figure 6. Junction capacitance versus reverse voltage applied (typical values)

Figure 7. Forward voltage drop versus forward current





Figure 8. Thermal resistance junction to ambient versus copper surface under tab




